The parties through their counsel stipulate to the following judgment.

1. This is a suit for patent infringement, with plaintiffs alleging that defendants' LA-1 water machine infringes their United States Patents Nos. 5,669,221 (the '221 patent'), 5,845,504 (the '504 patent'), 6,058,718 (the '718 patent'), and 6,182,453 (the '453 patent') (collectively the "Patents in Suit"), seeking damages and injunctive relief. Defendants counter-claimed alleging that they had rights in the Patents in Suit by assignment from Terry LeBleu and that the Patents in Suit were invalid and unenforceable because of inequitable conduct by plaintiffs and by applicants for the patents in suit

2. This court has jurisdiction pursuant to 28 U.S.C. § 1338(a).

3. Plaintiff and counterdefendant Worldwide Water, Inc., ("WWW - Inc.") is a Texas corporation with its principal place of business in California. Plaintiff and counterdefendant Worldwide Water, L.L.C. ("WWW - LLC") is a Nevada limited liability company with its principal place of business in California.

4. Defendant and counterclaimant Liquid-Air, Inc. ("Liquid Air") is a Utah corporation with its principal place of business located in California. Defendants and counterclaimants Nick Wells ("Wells"), Bernard Syauta ("Syauta"), Gregory Cameron ("Cameron") and Budhi Haryanto ("Haryanto") are individuals. Liquid Air, Wells, Syauta, Cameron and Haryanto are collectively referred to as Defendants. This court has personal jurisdiction over the Defendants and venue is proper.

5. The plaintiffs WWW - Inc. and WWW - LLC own each of the Patents in Suit, namely: United States Patents Nos. 5,669,221 (the '221 patent'), 5,845,504 (the '504 patent'), 6,058,718 (the '718 patent'), and 6,182,453 (the '453 patent'). No defendant has any right, title, interest or license in any of these Patents in Suit.

6. As between the parties, the Patents in Suit are valid and enforceable. "Valid" means that the United States Patent and Trademark Office correctly issued the patents. "Enforceable" means that the patent applicants and their attorneys did not violate their duty of candor to the United States Patent and Trademark Office.

7. Defendants will no longer manufacture or produce the LA-1 water machine.

8. Each party shall bear their own costs and attorneys fees.
